## **Detailed Final Report**

The project, "The Ontological Roots of Phenomenology", had been dedicated to the question, whether the central position of the question of ontology within the history of phenomenology is based on the phenomenology's fundamental methodology. The research was based on three hypotheses regarding the appearance of the ontological question in the different phases of the history of phenomenology. The research project made up of three parts: while, on the one hand, a.) the ontological question of phenomenology had already appeared among the early students of Edmund Husserl in Göttingen by the critique of the idealistic concept of the Husserlian methodology, b.) Martin Heidegger's concept on fundamental ontology radically changed the subject of phenomenology, in the sense of being-historical thinking, which constituted c.) the methodological dilemma in Paul Ricœur's thinking and concluded in the description of the short route and the long route of phenomenological-hermeneutical understanding. This way, the research project, "The Ontological Roots of Phenomenology", focused on the Heideggerian influence on the early phenomenological achievements and *vica versa* regarding the ontological quest in the history of phenomenology, which finally culminated in methodological questioning directed at reality in Ricœur's thinking.

Besides the annual achievements in the work towards the planned monograph, which in its present form consists of 115983 words and realized the three hypotheses of the project (1. The question pertaining to ontology by early phenomenology is undeniably related to the Heideggerian questioning on Being; 2. Due to previously unexpected research results, the output of the first hypothesis has changed the topic of the second part of the project, and the second hypothesis encompasses the research of the transition from the existential analytic to the being-historical thinking in Heidegger's thinking; 3. The phenomenological question concerning reality is, in its essence, an ontological question), the research project has been completed with international conference presentations and papers in the topic of the research.
